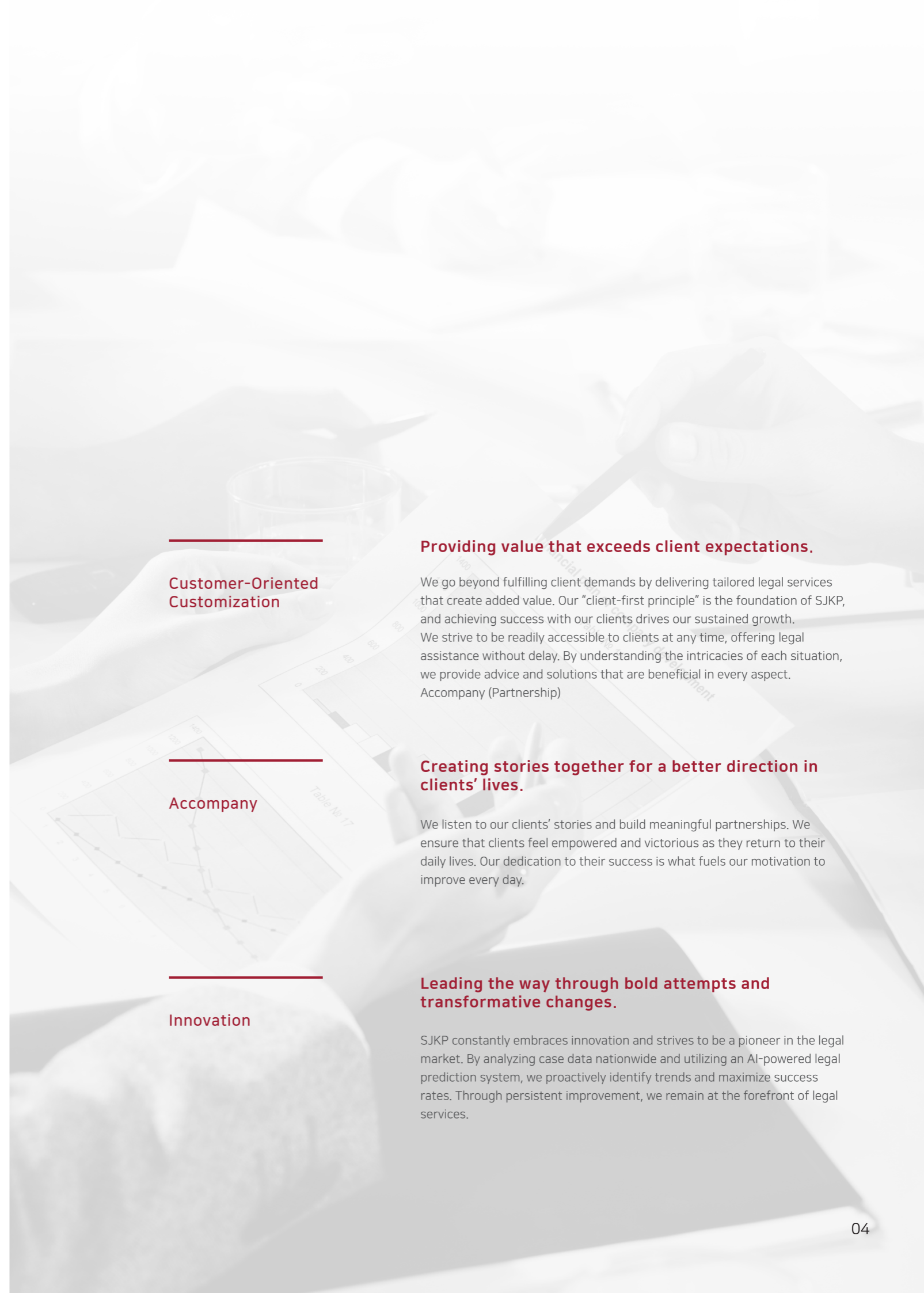
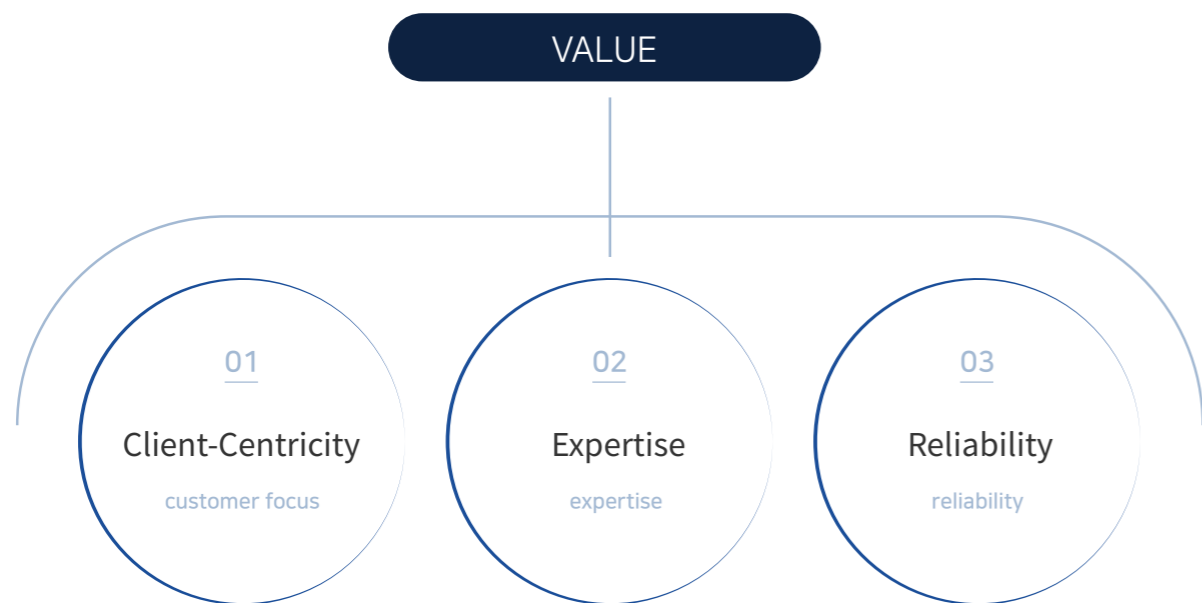

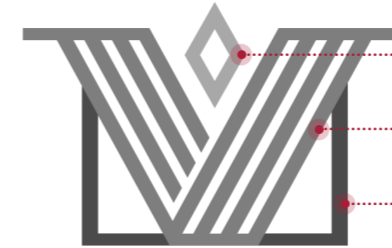


Daeryun's emblem symbolizes light, victory, and the meaning of triumph

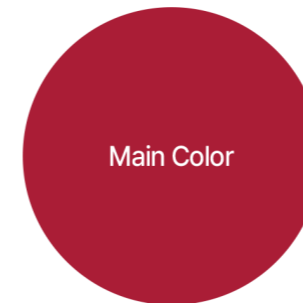
